The CAC usually meets quarterly, during the months of September, November, February and April.

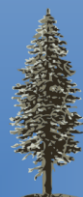
The public is warmly invited to attend CAC meetings. Input from the community is always welcome.

## What can the CAC do for me?

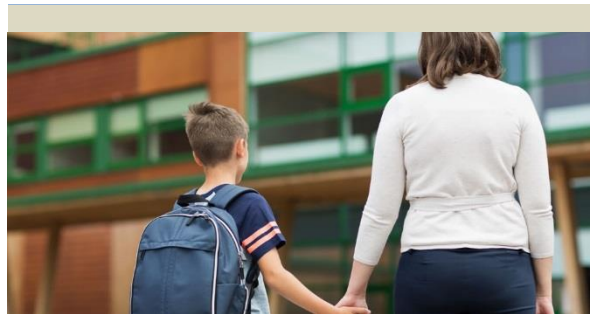
- Keep you informed about current and/or future programs and legislation affecting special education.

- Other members include school personnel, representatives from public and private agencies, students and adults with disabilities, or community members concerned about special needs children and young adults.
